This Privacy Policy ("Policy") explains how Astra UI ("we," "our," or "us") collects, uses, and protects your personal information when you access or use Astra UI, an open-source user interface (UI) library for React applications. By using Astra UI, you agree to the terms of this Privacy Policy. If you do not agree with this Policy, you should not use the Library.

1. Information We Collect

Astra UI does not directly collect personal data from users. However, in the course of using Astra UI, we may collect the following types of data through third-party tools or services integrated into the project:

- Usage Data: Information on how you interact with the Library, including performance data, error logs, and analytics regarding its usage.
- **Technical Data**: Information related to your device, browser, IP address, and operating system, which is automatically collected by third-party tools or services for performance and security monitoring.

2. How We Use Your Information

We may use the information we collect to:

- Improve and maintain Astra UI.

- Monitor and ensure the security and integrity of the Library.

- Service Providers: We may share certain data with trusted third-party service providers who assist in the development, maintenance, or support of Astra UI. These service providers are contractually obligated to protect your data and only use it for the purpose of providing the requested services.
- **Legal Compliance**: We may disclose your information if required by law or to comply with a legal process, such as a subpoena, court order, or government request.

4. Cookies and Tracking Technologies

Astra UI may use third-party analytics tools that may use cookies or similar technologies to collect data on your usage of the Library. These cookies help improve the functionality of the Library and may track your interactions, such as page views, error occurrences, and performance metrics.
